Scouting's impact on young people

In over 224 countries and territories, Scouts of all ages learn by doing, through a fun and challenging programme of quality educational activities with a strong focus on active citizenship and community service.

They develop key leadership and life skills that guide, encourage and enable them to lead positive action in society throughout their lives.

In fact, according to external impact studies, Scouts outperform their peers across nearly all categories of personal development.

Scouts scored higher than their peers in:

Active citizenship	+17%
Physical activity	+18%
Life skills and employability	+16%
Embracing diversity	+8%
Leadership skills	+12%
Empathy & supporting others	+9%

Spotlight on Scouts in Action

Humanitarian Action

Scouts are active members of the communities they serve, often at the forefront of humanitarian action, aiding when disaster strikes and developing long-term solutions and ongoing support in their communities.

Over 35,000 Scout volunteers reached 1.15 million Ukrainians in need of support during the crisis precipitated by the war in Ukraine. In partnership with UNICEF, they provided critical border assistance, translation services and psychological first aid. As a result, in 2024, World Scouting was recognised for youth-led humanitarian efforts in the UN report on youth, peace and security.

Ticket to Life

Ticket to Life is one of our flagship programmes designed to empower vulnerable children and young people, including children living on the streets, children with disabilities, refugees and children living in conflict zones. Over the past decade, the programme has successfully engaged more than 12,000 young people aged between 6 and 26, giving them opportunities to play, socialise and develop key life skills via a tailored educational programme of Scout activities. This is all done in a safe and nurturing environment, setting them on a path to a better life, so they can play a constructive role in society.



Champions of Nature

Scouts in Bolivia are championing afforestation by producing native plants to restore ecosystems in the inter-Andean valleys of Bolivia. It's not a quick or easy solution, but one which will create healthier natural forests and ensure the sustainability of entire ecosystems in the region for generations to come. Scouts continue to work with local partners and institutions to ensure the continuous supply of native seedlings at good rates for their own afforestation projects, whilst also covering the basic costs associated with the Scout nursery (gardeners, water). They estimate that they can produce 1500 to 2500 seedlings of native trees per year!
